Elkton was the site of our first 2017 rally, as well, and all who attended it voted unanimously to return in 2018! The owners treated us very well and they have offered us a nice discount from their 2018 campsite fees. By the same token, those who attended last September's Coast Rally at the Odd Fellows RV Park campground in Florence voted to return there this September and Kimm was able to lock in the same reduced rate as last year, even though they increased prices for others. ### **HISTORY of CHAPTER 9**

**Trailer Tracks Oct. Nov. 1986.** This issue reminded that chapter and co-op were "Separate entities each with its own officers". Chapter things were to go to Chapter Treasurer, Vera Fitzgerald and Co-op matters to Co-op Treasurer Penny Scheiner in Port Angeles, WA.

Also noted: "it costs about \$.49 to print and mail each issue of Trailer Tracks. With six copies a year, that leaves \$.06 of each \$4 membership fee to print the roster, rules and reg's plus buy supplies and equipment for the club.... Therefore, it has been decided to skip the December issue of Trailer Tracks."

The club then had 83 members who had Oregon addresses, 29 from California, 11, Washington; 8, Arizona; 2 Nevada; 4 Texas, and 1 each Idaho, Colorado, Kentucky, Ohio and Utah.

The co-op report in this issue is of particular interest if you can read between the lines. "The last three months have been confusing, upsetting time with all the letters, the return of your checks and the action of the Escapee Club. We hope all the upheaval has settled. Let's regroup. As SKPs we can do that. Let the past go...Your space will be reserved on the original list until March 1, 1987 if you send the \$7.00 which was returned to you."

The Editor also assures "The Board will be directed by the majority and will let you know what <u>you</u> think, not what we think."

Those who dearly wanted the coast (and probably some who were appalled at the squabble) had pulled out and membership dropped from 358 to 175 families.

It is interesting that nearby Oakland had been considered for the park. Oakland, however, wasn't sure they wanted the park: Betty Hyndman remembers Oakland feared "those old men might rape our young girls". In Oakland's defense it was in 1981 that the Rajneeshes were deported after committing criminal offences in Eastern Oregon. Oakland (and also Sutherlin) feared that the Escapees might be another dangerous sect.

The following information comes from old reports given by our Chapter 9 reporters in the Escapees newsletters of the 1980s.

Early 1986 Vel Boge had introduced the idea of a co-op designed to "utilize the beautiful Oregon land and trees

to create an "Oregon Park concept"." This was after members rejected the coast sites and before they had seen our beautiful hillside site.

Who was Vel Boge? He was Vice President; Pres. was Verne Hansen, Feasibility Chair. was Ed Strieger, Membership Survey Chair, Doris Field, and By-Laws Chair, Bill Field. <u>Before May of 1988</u> the Land Search Committee (Roy and Virginia Adams, Bill and Jean Moss) were looking in the Willamette Valley. Members surveyed (by Doris Field) wanted "near a small town" with city sewer, 50 amp, phones and cable.

Imagine yourself one of the remaining 175 families; almost half of your friends (maybe enemies too!) are gone and you're being prodded to soldier on!
