

SITUATION STATUS REPORT

April 6, 2020

The latest information on Covid-19 can be found on the Park's website.

What is new?

- A contingency plan to maintain mail service and offices functions has been developed.
- While the Park does not endorse them, grocery shopping and delivery services have been identified to Members and guests.
- From Dr. Bob Dannenhoffer, Douglas Public Health Officer *"This is the most critical time for us to continue to try to contain this with social distancing. It may seem like this is dying down but it's actually the calm before the storm."*

Assumptions:

1. For planning purposes, Epidemic will not crest before June 1.
2. There will be one or more local cases.
3. Members will need help with shopping.
4. Members may need prepared food.
5. Most Members who travel will return to the Park in May.
6. The Park may become a refuge for Escapees stranded along the west coast.
7. Residents will voluntarily comply with Federal, State and Park's corona virus response measures.

Situation Status:

By action of the Board, the Park's response to the Covid-19 Pandemic, is being managed by the Emergency Preparation Committee Overhead Team until June 1, 2020.

1. Visitors and Members returning to the Park are asked to self-quarantine for 14 days. That means:
 - Do not enter the Clubhouse including the laundry room.
 - Stay on assigned lot and travel only when essential.
 - Do not invite guests to your lot.
 - The Welcome Committee is standing down.
2. Office and Mailroom have restricted entry – One at a time in both Office and Mailroom.
3. Clubhouse social activities: Use of Clubhouse for any social or entertainment activities is prohibited until further notice.
4. Laundry Room use is restricted to two-hour blocks via a sign-up scheduled posted at west door.
 - Sign up for you block of time – **Enter Laundry Room only during your block of time**
 - **Please cooperate so that our laundry can be kept open!**
5. Propane delivery will continue under the normal dispensing hours and there is a contingency plan for disruption of the supply chain.
6. A plan to assist Members with shopping will be developed if needed.
7. Rick DeYoung is the Park's Information Officer and Liaison to the City.

Communications Goals:

- Members will be kept up to date.
- The Park's website will be kept up to date.
- Block Captains will maintain connections to neighbors and report significant changes.
- Rick DeYoung will monitor Ch 6.
- Members and guest are requested to display their Red/Green Signal cards.
