## **GUIDLINE RULES**

## **OREGON TRAILS**

Chapter #9 of the Escapees Club, Inc.

- 1. Rallies will be selected from suggestions made by members.

  The Rally Hosts for each function will be volunteers. An attempt will be made to vary locations.
- 2. The Rally hosts will furnish the following information to the Chapter corresponding secretary for publication in Trailer Tracks.
  - A. Name of campground, address and telephone number.
  - B. Price and facilities available.
  - C. Directions to locate campground.
  - D. Designation of potluck nights and other planned activities.
  - E. Name, address and phone number of Hosts and Assistant Hosts.
  - F. Date and time of rally.
- 3. To facilitate planning and as a courtesy to our volunteer hosts, members will, when possible, notify the Host by mail or telephone if they plan to attend the Rally. Notice is not mandatory and members are encouraged to attend even if they have been unable to provide notice.
- 4. It is the responsibility of each member to maintain his own copy of the Bylaws, Guideline Rules and Member Roster by amending them as specified in Trailer Tracks.
- 5. Prospective members of the Escapees Club, Inc. may attend two Chapter rallies, if they desire, prior to joining the Escapees Club, Inc.
- 6. Prospective members and guests will be provided with name tags by the Rally Hosts.
- 7. Members are expected to keep their campsites clean and any member who brings a pet shall:
  - A. Keep it in the rig or on a leash when the pet is taken from the rig. The leash shall be short enough to allow complete control of the pet.
  - B. Keep the pet controlled from excessive vocalizing.

- C. Arrange supervision so as to prevent disturbances during absence of the owner.
- D. Pick up and dispose of any droppings.
- E. Keep it away from the social area.
- 8. The Rally Hosts shall collect and turn over to the Treasurer a small fee of \$1.00 or more, if needed, from each person attending the rally. Said fee shall be paid in full before the member leaves the rally. This fee is to be used to defer the expenses of the rally. Any reminder beyond expenses shall go into the Chapter's treasury to defray Chapter expenses.
- 9. When requested by any member, a "NO SMOKING" area will be established for such functions as shared meals and meetings. Members shall respect such areas and refrain from smoking in them.
- 10. In consideration of others, members are requested to refrain from running generators before 8:00 A.M. or between 1:00 and 4:00 P.M. or after 9.00 P.M.
- 11. Children attending rallies shall be under the supervision of a responsible adult at all times.
- 12. If any member's action are offensive it shall be up to the grieved party to discuss the action with the offender first and try to reach a compromise. If the parties concerned have attempted to settle a dispute and have been unable to do so, the grievance shall be taken to a member of the Executive Board for settlement. A member may be asked to leave the rally, or, if circumstances warrant may be expelled from the chapter upon presentation of such evidence that the member's behavior is deemed to be unacceptable to the majority of the membership.
