Calls that may violate FCC policy includes calls made prior to 8am or after 9pm, calls made if you are listed on the Do Not Call registry, and people calling from fake or randomized numbers. Register your phone number on the national Do Not Call registry at www.DoNotCall.gov. If you continue to receive suspicious calls or texts, file a complaint at consumercomplaints.fcc.gov and provide the phone number, name, date, and time of call.
