Timber Valley Rules and Regulations

No feeding of the deer or any other wildlife within the park boundaries. Small bird feeders are allowed. (07/01/01

Oregon Statutes:

In Oregon, feeding wildlife, including deer and elk, is generally discouraged and can be illegal, especially if it leads to habituation or poses a risk to humans or the animals themselves.

Why it's discouraged:

- **Habituation:** Feeding wildlife can cause them to lose their natural fear of humans and become dependent on human food, which can lead to conflicts and safety issues.
- **Health Risks:** Human food can be unhealthy or even dangerous for wildlife, and feeding can also concentrate animals, increasing the risk of disease outbreaks.
- **Habitat Damage:** Concentrating wildlife in one area due to feeding can damage their habitat through overgrazing and other means.

• **Respect wildlife:** Enjoy wildlife from a safe distance and avoid any actions that could harm them or make them dependent on humans.

New Signs

New signs have been placed around the park to make you aware of the poisonous plants we have in the park. Poison Oak is recognizable especially in the fall when the leaves turn color. The Spurge Laurel leaves, stems and berries are very poisonous to people and pets. It is an invasive plant that grows abundantly in this park.

Flooding

Water was pooling very high behind Lot 197 (Jimmy and Julianne) Sunday Morning with some slippage over drainage ditch and berm. Thanks to the huge help of Dar Hoch, and Wade and Debi Norton, along with their shovels, (in the pouring rain) water was diverted so that it joined up with the main drainage ditch that cascades under the bridge between Lots 198 & 199.

A more permanent solution is needed ... especially if this area is due to be clearcut.
