## **New Business**

**Lights by Office:** Susie Varner brought up needing to address the lights by the office. One end of the Christmas lights by the office are not working. They are one continuous strand so it needs to be replaced. We need about 200 feet of outdoor Christmas lights. If anyone sees any for sale for a good price, let Chris know.

### **Red tag for the stove:**

Fire Marshall says the hood we have is not the right size for the stove we have. Structural changes, permits and a fire suppression system cost \$10-20k or we

can get a new smaller stove. Waiting for the board to hold a special meeting to discuss.

If we don't address the issue by either replacing the stove or the hood vent, and have a fire, our insurance may not cover it if we ignore the red tag. If we keep getting red tagged the Fire Marshall could have the gas to the building cut off.

Chris has found 4 smaller gas stoves ranging around \$3500 - \$5,000. Chris will look into a commercial electric stove. It would need some rewriting and permitting to accommodate the electric stove. Jill looked up some prices for electric commercial stove and they are over \$20,000

In addition, the stove is down with a faulty thermocouple. Dick Shanahan is working on getting the warranty company to send a repair person out.

Once the stove is fixed, we can sell it and put the money back in the CARF account. Question- is the warranty transferable to the new owners? Chris will ask Dick.

The estimates and suggestions were delivered to the board today.

Lindy talked about having a Valentine's dinner and dance. Lindy was not able to make the meeting, however, Chris will ask Lindy to see if it's viable. If it's viable, there will be a flyer, and information posted.
