### **Budget for entertainment**

Eric Moosman proposed an on going budget of \$1,000 per fiscal year to coordinate outside entertainment with a cap of \$250 per event. Old Time Fiddlers was well received 68-70 or more people attended.

Motion is to have an ongoing budget of \$1,000 per fiscal year with a cap of \$250: Cathey made the motion and Jill seconded

### **Discussion**

Jill had a concern of allocating \$1,000 out of our treasury. Concern that it is taking close to half of our funds without knowing whether we will get money back.

Robin asked if we could charge for the entertainment and the consensus is no

Joy suggested we need to know who are coming and then decide if we can fund and schedule it.

Chris explained the thought is to have fluidity so we can schedule and pay a deposit if needed without needing approval.

Mary feels that's too much money to commit to.  
Anita is also not supportive.

### **Cathey withdrew motion**

Jill asked, what about \$250 allocated for entertainment? Then allocate another \$250 on a case by case basis.

Cathey said most local people play or perform for tips. But it would be nice to have some money to use as a deposit for those that require payment.

Jill made a motion that up to \$250 be allocated for entertainment, to be reviewed on an as needed basis. Mary seconded.

### **Discussion**

Sharon \$250 be preapproved up to \$250.00

Peggy Russell questioned what defines entertainment

All in favor. Approved by majority vote. Passed

### **Memorial dedications**

- Plaques on time capsule monument. 3 x 5 plaques. Who will pay for them? Cost would have to be borne by family or friends.

Sharon- it's becoming involved. Need to decide what is going to be in the time capsule and the cost. Trying to decide what material to use to seal the capsule. Wood will rot, metal? Sharon suggested the plaques should be smaller to allow more plaques. Sharon may ask the high school metal working group if they would be interested in making a plate to close off the time capsule.

Suggestion- Loved ones should pay for the plaque but we would need the park to attach them.

- Correction to notes from April- Anita said Trees are not the problem for the mowers. Bring to the board and landscape Committee and park manager. As long as they are limbed up. The mowers won't be a problem Peggy suggested to ask the city what kind of trees. Come to social hour as the mayor might know.

Proposed to board, if tree dies or is cut down in the common area, a new tree should be planted. Note this was brought up to the board at the agenda meeting. There didn't seem to be opposition, however the direction was to submit the request for a tree to be planted to the landscaping committee.

**Memorial Day** Nothing for Memorial Day this year.

**Fourth of July** Saturday July 4 picnic. 250 years! Karen will coordinate it. Golf cart/wagon parade. We want lots of people to sit outside as parade goes by. Sit with neighbors. Parade in the morning, bean bag baseball early afternoon.

In the evening. Grill your own meat/entree and a side dish to share. Two half sheet cakes from Costco. We only ate 1.5 sheets last year so perhaps one half sheet and a quarter sheet. Joy is asking J & J to pay for it. Joy will get dollar amounts and will ask for a vote for the amount in June.

**Annual Meeting** Barbara Russell may be in charge food. She is out of the park. Needs help serving, setting up and cleaning up.

Daphne will fix Team Up with correct dates for Timber Valley Days and Annual Meeting.

To do several pictures would either require a paid subscription or multiple people using the free option. No decision was made though likely the pictures of the park will be on the big screen.
